Code of Ethics

"Sport, Conservation, Integrity"

- Obey and respect the local regulations and conventions that govern fishing in your chosen area.
- Purposefully conduct yourself in such a manner so as to minimise any negative impact on the fish's environment. Being mindful that anchoring and speed restrictions is as important as preventing littering, pollution and habitat destruction.
- The fisher's environment should be protected as well as the fish's. Do not indulge in littering, in particular with discarded tackle. Disposal of offal and unwanted bait should be undertaken in a manner that is both environmentally sound and publicly acceptable.
- Respect the rights and interests of others especially those other anglers and commercial fishers who are legally participating in the fishery.
- Be aware of the relationship between the fisher and their quarry and understand that the choice of the individual is important when dealing with a capture.
- Respect the rights of property owners including those who exclude access for personal or cultural reasons and negotiate access to waters rather than trespass.
- Participate where possible in scientific, educational and community programs that benefit the fishery or recreational anglers.
- Fish taken should be killed quickly and should be prepared and preserved in such a manner as to minimise spoilage and waste. Where a fish is not wanted, it should be returned in such manner that maximises its chances of survival. Wanton unnecessary destruction of undesired species is unacceptable.
- Be aware of the natural range of fish species and do not move live fish, especially for use as bait, outside their normal range.

THE AUSTRALIAN NATIONAL SPORTFISHING ASSOCIATION LTD (ANSA)

The Australian National Sportfishing Association (ANSA) formally started in 1967 when a group of dedicated sportfishers met at Yorkeys Knob in Cairns. Fourteen “barefooted yobbo’s” under the stewardship of Vic McCristal and George Bryden put into some order their ideas of fishing for sport and enjoyment. From that time on, they determined to promote sportfishing under the motto “sport, conservation, integrity”.

Today membership of the Association is approximately 200 clubs, containing over 5000 members. The Association is represented in all states and territories and maintains affiliation with the International Game Fishing Association (IGFA).

ANSA is an association of clubs and individual members. Clubs are geographically organised into state or territory branches. Each branch has an elected executive responsible for the local activities in each state or territory.

At the national level ANSA is responsible for coordinating and printing “The Fishing Rules”, maintaining a comprehensive record chart and presenting the “Master Angler Awards”. It also selects the recipient of the “Meritorious Capture” award. Nominations for this award are submitted during the year.

Queensland Branch Inc. conducts an annual conference in Yeppoon. This is traditionally held in August. Each year, guest speakers representing government, industry and science present information on how their organisations will impact on recreational fishing in Queensland. The conference provides an opportunity for members to meet people from other clubs and branches as well as fisheries management, scientific representatives, and enforcement. The branch annual general meeting is held as a part of the conference allowing members to see their club delegates elect the new executive and debate policy.

Queensland Branch Inc is affiliated with Sunfish, the peak recreational fishing body recognised by the Queensland government.

Queensland Branch Inc. is also responsible for vetting and processing national and state “Master Angler” awards, national and state “Record” claims and maintaining a Queensland Branch Inc. record chart. It is also responsible for conducting six state wide angling competitions. The ANSA Qld Species Challenge is held on the last full weekend of September each year. The Top Ten, Top Club, Bob Carruthers Memorial Trophy, Hamar Midgley Flyfishing Award and Length Based Competitions run consecutively during the whole fishing year.

Queensland Branch Inc. produces and edits the quarterly newsletter “Sportfish Queensland” which is issued individually to all members.

Queensland Branch Inc. in cooperation with the Queensland Department of Primary Industries and Fisheries runs a comprehensive fish tagging program (Suntag), which is encompassed by the national tagging program Austag.

All clubs affiliated in Queensland must be incorporated under the Incorporations Act and ANSA Qld Inc. has undertaken to assist clubs in this endeavour. Part of incorporation is that a Public Liability Insurance policy be maintained. ANSA Qld. Inc. holds the policy on behalf of the membership of ANSA Qld. Inc.

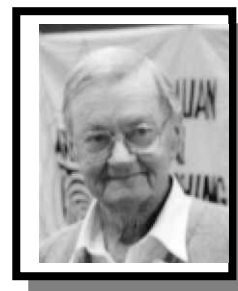

RON DEMPSTER AWARD

THE ERIC MOLLER AWARD

This is the most honoured award offered by ANSA Queensland Branch Inc. to an ANSA Qld member.

Submissions are prepared by clubs who nominate a worthy member prior to the Annual Conference at Yeppoon in August.



The guidelines are laid out below:

- 1 The trophy is a perpetual one, remaining in the control of the Queensland Branch and can be won by an individual once only. A facsimile of the award will be sent to the Club for presentation to the successful nominee.
- 2 Only registered members of Clubs affiliated with ANSA Queensland Branch Inc are eligible for nomination. The submissions must be formulated and forwarded by Clubs, NOT INDIVIDUALS, and only one nomination per Club is acceptable per year.
- 3 It is not in keeping with the ethics of the award for a member to be asked to be, or expect to be, nominated. In many cases the nominee is unaware of the nomination.
- 4 In assessing each candidate's profile, contribution to the person's Club and angling achievements will be considered on an equal basis.
- 5 The Club is to write a submission, which sets out their nominee's dedication and assistance to the Club and the ANSA principles and their angling versatility. Fishing versatility may include achievements in progression towards Master Angler Awards, participation in bluewater, inshore, landbased, freshwater, tagging etc.
- 6 The Award is designed for an all round angler who catches fish in most conditions and contributes meaningfully to the well being of his/her Club and participates regularly.
- 7 The nominations will be read to the Club delegates present during the Annual Conference. The delegates will then vote for the recipient of the Award by means of a secret ballot.
- 8 The decisions of the delegates present will be final and no correspondence will be entered into after the result is announced.
- 9 To be nominated by one's Club is an honour in itself, however there can only be one winner each fishing year and submissions for unsuccessful nominees are encouraged to be resubmitted.
- 10 The announcement and presentation of the Award will be made on the Saturday night of the weekend of the Annual Conference.
- 11 All Senior and Junior members are eligible to be nominated.

SUNTAG 2012



Suntag is ANSA Qld's fisheries research program and is a joint program with the Fisheries Queensland. Suntag is managed by Infofish Australia on behalf of ANSA Qld Inc.

Suntag provides members of ANSA Qld the opportunity to contribute to knowledge on key recreational species that are important to our members. Data of importance collected by Suntag includes tagged fish, catch and effort, released fish rates and hooking locations that are used in assessing fish survival.

As at the end of 2011 Suntag has records of over 655,000 fish tagged, over 52,000 fish recaptured, over 30,000 fishing trips and over 73,000 hooking locations. As well as maintaining ANSA tagging data Suntag also stores data for projects involving tagging for Fisheries Queensland and Fish Stocking Groups. Suntag is now considered to be the primary database on fish tagging in Queensland and one of the largest recreational tagging databases in the world.

Involvement in Suntag by ANSA members leads to a greater understanding of the role of research in fisheries management, a stronger commitment to the results of research and a more knowledgeable recreational fishing community. Information on the achievements of Suntag are published in an annual Suntag Research Report and all clubs and frequent taggers involved in tagging are provided a copy of this report.

In 2006 an online database was introduced and this was upgraded in 2011 and 2012. Some of the features of the Infofish 2012 database are:

- Online access to authorised persons from anywhere in the world
- Excel spreadsheet for collecting details of fishing trips and tagging for upload to the database
- Ability to store photos or video of individual tagged and recapture fish
- Delivery of tag and recapture certificates by email direct from the database
- Database linked to Google Earth to provide visualisation of Suntag data

The database is complemented by the Infofish/Suntag websites www.info-fish.net and www.info-fish.net/suntag which provide access to information on Suntag. The websites includes:

- Tagging manual and forms to use
- Suntag projects and awards
- Online reporting of recaptures with instant feedback from the database
- Ability for taggers to review their records in the database
- Access to news bulletins (also emailed to Suntag network)
- Online membership to Suntaggers (for individual members that want to take part in Suntag)
- Infofish Shop for the purchase of tagging equipment

Suntag is a project based program and a list of all current projects is available from the website. These projects are designed to meet specific objectives or to support other research. Reports on various projects are available from the website.

Suntag has in place a number of awards and rewards to recognise the efforts of taggers. Details of the awards are available from the website and the requirements for awards were simplified in 2011. The awards include:

- ❑ Tagging Achievement Awards
- ❑ Tagging Excellence Awards
- ❑ Frequent taggers (having tagged over 1,000 fish)
- ❑ Top tagger each year (Phil Brooks Memorial Tagging Award)



ANSA CODE OF PRACTICE FOR RELEASING FISH

The following code of practice, revised and adopted in March 2002, is recommended to ANSA members where fish are intended to be released. Fish should be caught, handled and released in a manner that will ensure that they are returned to the water in as healthy a condition as possible.

TACKLE TO USE

- Use tackle that will land a fish quickly to minimise exhaustion however avoid bringing in the fish too quickly as this may increase the risk of damage from the fish thrashing about once landed
- Use artificial lures with barbless hooks where possible as that results in fewer fish being gut hooked and hooks are easier to remove without further damage to the fish.
- For bait fishing use hook patterns such as circle hooks to maximise the likely hood of the hook being lodged in the jaw and minimise damage through gut hooking.
- Use a de-hooker such as a “Hookout” or long nosed pliers for quick removal of hooks taking care not to damage the fish further. If the fish has swallowed the hook do not attempt to remove it. Leave the hook where it is and cut the line as close to the hook as possible.
- Use a knotless landing net as this removes less slime and reduces time out of the water for the fish. Gaffs should never be used.
- Use a fish grip devise to assist in handling a fish for release.

HANDLING AND RELEASING FISH

- Plan ahead and make sure you have all equipment close at hand. Work rapidly but without haste to ensure the fish is out of the water for the least amount of time.
- Do not place a fish on a hot, dry surface for hook removal, use a wet towel on which to rest the fish and use wet hands when handling it.
- Do not put fingers inside gill cover or eye sockets when handling fish for release. A fish grip device may be used and the body of the fish should be supported at all times when lifting to release the fish.
- Direct sunlight can damage fish eyes so ensure that they are shaded during time out of water. This will also help to calm the fish while handling.

REEF FISH CAUGHT IN DEEP WATER

Reef fish caught in deep water may require special handling to improve survival. When fish are brought to the surface from depths of around 20m or more, the gases in their swim bladder may have been expanded significantly. This condition can be easily detected as the stomach of the fish is pushed out of its mouth.

- Venting of the air in the swim bladder may increase the survival rate of the fish that are released by allowing them to return quickly to the bottom. There are a number of ways of venting fish and the most appropriate for a particular species should be used.
- Options such as weighted lines to return a fish quickly to the bottom may be considered as an alternative to venting especially if there are predators present.

There is a **National Code of Practice For Recreational And Sportfishing** published by **Recfish Australia**

It is recommended that **ALL** Recreational Anglers become familiar with this code before venturing out into your favourite fishing spot

GENERAL RULES:

1. Only members affiliated with ANSA Qld Inc (through membership of an affiliated ANSA Qld Inc Club or Qld Sportfishers) **AND** appear on the ANSA Qld Inc Membership Register prior to the start of the competition are eligible to compete.

Disabled Anglers

These rules are not intended to disadvantage disabled anglers. Any decision for dispensation regarding the application of these fishing rules, for any ANSA fishing activity by a disabled angler, is the sole prerogative of that angler's club executive. Disabled anglers who are unable to operate a manually operated fishing reel, may use an electrically operated model. ANSA members and clubs are encouraged to assist disabled people in the participation and enjoyment of our sport.

2. Lines manufactured specifically to meet ANSA / IGFA line class limits, must be used on all ANSA Qld Inc line class competitions. Other lines may be used for All Tackle Division/Species Challenge.

3. If an ANSA **Qld** Record is submitted using manufactured pretested line, a line sample is not required with the claim and the line is taken on its merit by the manufacturer's test results.

4. If a non pretested line is used, the onus is on the angler to have an independent test and documentation must be supplied with the claim. If the Queensland record claim is also a National record claim and the line is non pretested, then the line test conducted by National shall then be accepted by Queensland.

5. If a manufacturer's pretested line is for both a National and Queensland claim and the National test result fails, the line will still be accepted by Queensland on the manufacturer's test results.

NB: Line samples are still required when submitting National Record claims regardless of the line used.

6. Master captures may be weighed in boat and the fish released, with the angler's scales checked against certified scales for verification (read in conjunction with National rules)

7. Captures eligible for ANSA Qld Master Claims can be caught within ANSA National boundaries.

8. A length to weight ratio may be used to measure and calculate points while fishing in ANSA Qld competitions. The Formula is available for billfish and, at present, for 38 species on the ANSA Qld species list. The Billfish formula is available on page 16 of this handbook. The length to weight information for the other species is available upon request from Ansa Qld. Events Co-ordinator, or State Recorder, in print form or on CD by Mail, or electronically by Email.

9. If no measurements are taken Billfish and Sharks (ALL) captured and released may be counted in the tally of an entrant for masters claims, State Championships and/or Top Ten Competitions. Such fish will score 100 points only, regardless of the line class used.

10. If a National record claim is also eligible to be claimed as a Queensland record, it will automatically be recorded as a Queensland Record claim. There will be no cost incurred. The same form can be used for either National or Queensland claim, however each must be identified.

11. All species in the ANSA Qld Inc Handbook are eligible for Queensland Record or Master Claims. (Some may not be eligible for National claims, however)

12. Captures eligible for ANSA Qld Record Claims must be caught in Queensland waters.

13. ANSA Qld Record claims shall be at least 100 points for Seniors and 80 points for Juniors

Record / Master claim forms can be downloaded from the website www.ansaqld.com.au

- 14. As per National Rule, the age of a Sub-junior shall be up to and including nine (9) years of age.
- 15. As per National Rule, the age of a Junior shall be from ten (10) years to fifteen (15) years of age inclusive.
- 16. For ANSA QLD competitions, anglers registered with ANSA Qld as Juniors or Sub-juniors as of July 1 in each year, will remain in that category for the duration of the year.

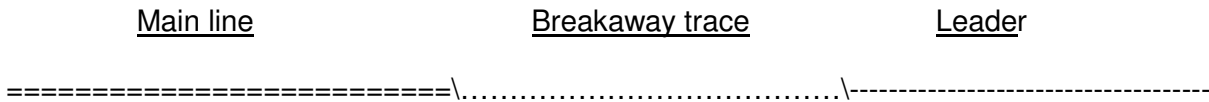

Line used for the breakaway trace in this Division must be manufactured pretested line.
 Reason: Under the Australian Standard for Line Testing, a proper test cannot be carried out due to the length of line supplied for testing i.e.: 0.5 to 1M.

In this Division, there is no change from sportfishing tackle equipment and regulations except for the “backing rule” which should be deleted for this Division.

Tackle specifications:

- Main line – any material except metallic
- Breakaway trace – line class – must be pretested and at least one class lighter than main line.
- Minimum length 0.5 metres, maximum length 1 metre.
- Leader – as per Division 1 – currently 1.5 rod lengths maximum, no minimum.
- Wire trace included in the 1.5 rod length if being used.



ALL TACKLE DIVISION

No line class required for this division i.e. Braid, Gel spun or heavy line classes. Equipment must conform to ANSA Requirements

For Qualification

- Fish must be at least 1.5 times larger than the ANSA Qld. Inc. species list min. legal lengths
- Any fish captured that qualifies as above will score 150 points
- An angler may submit any number of species but no more than 1 of any species
- Angler must record the overall length of each species on the form provided to be used to determine a winner in the case of a tied result. A formula held by the State Convenor will be used to determine the winner.

An example could be a Spotted Mackerel. It has a legal length of 60cm.
 (60cm x1.5 = 90 i.e. score of 150 points). The angler who amasses the greatest score is the winner. **NB. The fish may be kept or released.**

NB. National Rule – For All Tackle Masters claim refer to Trophy Lengths as per National Handbook or National website www.ansa.com.au

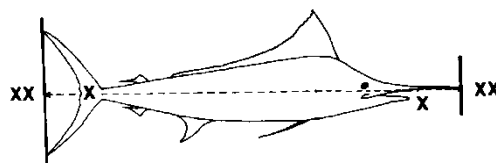

2. Awards shall be for the following:

- a) Senior Male
- b) Senior Female
- c) Junior Male
- d) Junior Female
- e) Sub-Junior Male
- f) Sub-Junior Female



3. A junior competitor is one who has attained the age of ten (10) years of age but not sixteen (16) years at the start of the competition. A sub-junior competitor is one who has not attained the age of ten (10) years at the start of competition. NOTE: Ages for junior and sub-junior is taken as at the 1st of July in each year, i.e., if the person starts the competition as a sub-junior or junior they will remain in that category for the period of the competition.

4. Anglers may continue to improve their score throughout the year.

5. No nomination is required. Registered financial membership of ANSA Qld Inc is necessary.

6. The angler may fish anytime and anywhere within the ANSA National boundaries for the period of the competition. There is no obligation for members to compete in or enter the competition.

7. There are no restrictions on fishing divisions to allow the angler maximum flexibility for fishing.

8. The winner in each category will be the angler with the maximum number of species (10), except in the case of a tie, which will be decided by the highest total point score. Submissions must include Species and points scored to determine the latter.

9. Fish may be weighed whole. No allowance can be made for fish that are gilled and gutted.

Submissions for the Annual Top Ten trophies should be made by the appropriate club official at the end of the angling year and must be in the hands of the Convenor by July 31st.

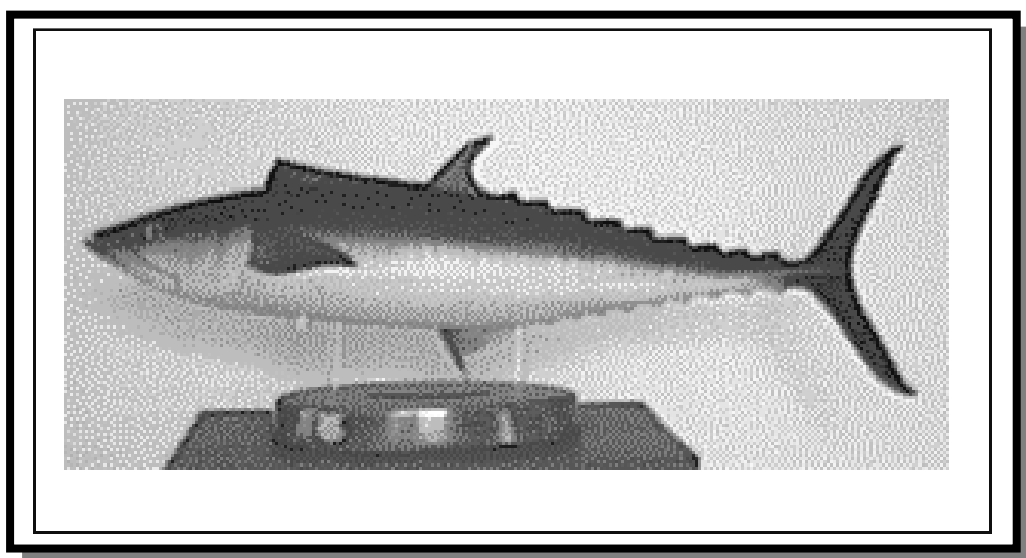

The competition will have a **set species list that can be decided each year** at the ANSA State Conference and will run for that year.

The duration of the competition will be determined by the membership

Fish can be kept or released

The competition will be operating over the internet through the ANSA QLD web site

www.ansaqld.com.au

Anglers will submit their results to the events Co-ordinator by email or by post who in turn will place the results on to the site and update the results as they are surpassed.

Taggers may use their tagged fish to enter this competition

The rules are very simple and they are as follows

Rules:

- Capture to be submitted on capture sheet (available at www.ansaqld.com.au) within 21 days to be eligible for the competition
- To beat a current capture, the new one must be at least 5 mm bigger (all measurements in millimetres) than the current capture. IE, to beat a 505 mm Bass, you need a 510 mm Bass
- At the end of the fishing year, all species are reset to zero
- Fish may be kept or released
- No line class or divisions as long as tackle meets ANSA requirements
- Only two categories, Seniors & Juniors
- Winning angler gets a certificate with a picture of that species used as a watermark on the certificate
- The Species list will be set by State Executive and will run for the following year. The current Species List can be viewed on the ANSA Qld website
- Minimum and maximum lengths apply as per ANSA species list and captures must comply with all Fisheries Regulations
- Fish is to be measured using DEEDI length regulations and/or ANSA Qld minimum length, but caudal fork length will be the measurement used for the determination of longest fish of each species. Short measurement for billfish and sailfish is also to be used. Refer website for detailed drawing
- Two photo's are required to enter any fish in the Competition. A mandatory photo of the fish on an acceptable measuring device, (the side of the boat in the case of billfish/sailfish) with both head and tail centred and clearly visible, and an optional photo of the fish being held by the angler. This is to assist with correct species identification and measurement of entries. The photo of the angler will be the preferred choice for publication on the web, but if unavailable the mandatory photo will be used.

The competition will be operating over the internet through the ANSA QLD web site www.ansaqld.com.au

Anglers will submit their results to the events Co-ordinator by email or by post who in turn will place the results on to the site and update the results as they are surpassed.

Taggers may use their tagged fish to enter this competition

The rules are very simple and they are as follows

Rules:

- Anglers must be a registered financial member of ANSA Qld
- Capture to be submitted on capture sheet (available at www.ansaqld.com.au) within 21 days to be eligible for the competition
- To beat a current capture, the new one must be at least 5 mm bigger (all measurements in millimetres) than the current capture. IE, to beat a 505 mm Bass, you need a 510 mm Bass
- At the end of the fishing year the sheet will be reset to zero
- Fish may be kept or released
- Tackle must meet the requirements set out for Lurefishing
- Winning angler gets a framed certificate with a picture of that species used as a watermark on the certificate
- Minimum and maximum lengths apply as per ANSA species list and captures must comply with all Fisheries Regulations

ANSA QLD SPECIES CHALLENGE

RULES

1. RULES

The rules of the ANSA Qld Species Challenge shall be in accordance with the "Rules of Competition, ANSA Queensland Species Challenge" as set out below.

2. VENUES AND BOUNDARIES

All fishing to be in Queensland waters or from boats launched between the Tweed River and the Northern Territory border. If a fish is hooked within the boundaries and an angler needs to move outside of them to land the fish, then it shall be an eligible capture.

3. HOURS OF COMPETITION

The Challenge commences at 2400hrs on Friday and concludes at 1400hrs on Sunday of the weekend of the competition. A fish hooked prior to the cease fishing time and then captured after the cease fishing time may count in the angler's tally.

4. CHALLENGE MEETING

Each club is to hold their own Challenge Meeting which is to commence by 1600hrs on Sunday and to be completed by 1800hrs on the same Sunday. All fish to be weighed/score sheets and/or photos must be in the Challenge Meeting area by 1600hrs

5. NOTIFICATION OF RESULTS

Each club or zone shall notify the Events Coordinator or a nominated assistant of their final results no later than 1800hrs of the day of the Challenge Meeting. Provisional results will be issued as soon as possible. Phone, fax or email the information on FORMS on the day after the Challenge Meeting.

6. RESULTS SHEETS

Results sheets are to be sent by post to the State Convenor within fourteen days. All forms are to be included. Failure to submit all forms, within fourteen days from the end of the competition, to the convenor, will negate any opportunity to claim a win.

7. COLLATION OF RESULTS

In order to have the results forwarded in a uniform format, only the forms provided or downloaded from the ANSA Qld website www.ansaqld.com.au will be accepted. NB. Please feel free to copy any extra forms from the ones provided

8. TACKLE

The tackle and method shall conform to the ANSA Fishing Rules as per ANSA Qld Inc. Handbook.

9. SCORING SYSTEM

All ANSA Queensland Eligible Species are acceptable, and 1 of each species is the maximum allowed. There are no limits on number of species caught.

The winner of the ANSA Qld Species Challenge will be the angler capturing the most individual species, and in the case of a tie, the ANSA Fight Factors of all species caught by those anglers will be used to determine a winner. If there is still a tie, this will be declared and additional certificates/medallions issued.

Only one fish per species can be entered for individuals or teams e.g. if 3 Team members each catch a Golden Trevally, each individual can claim the species, but the Team can only claim one Golden Trevally

10. ELIGIBLE SPECIES

- a) Shall be only those species listed in the ANSA Qld website (download the latest Eligible Species List before the event). Where legislation precludes the taking of any fish by species, size, season, location or any other such criteria, then that fish is not eligible.
- b) All fish must be in accordance with the ANSA Qld Eligible Species list minimum length, and/or the minimum Queensland Fisheries legal length, whichever is the greater
- c) No limit to number of species or number per species while Tagging.

Refer to "Eligible Species List" for eligible species and fighting factors, with E.M.Grants "Guide to Fishes", "Fishes of the Great Barrier Reef and Coral Sea" by J.E. Randall, G.R. Allen and R.C. Steene and "Marine Fishes of Tropical Australis and South East Asia" by G. R. Allen, "Freshwater Fishes of Australia" by G.R. Allen, S.H. Midgley, and M. Allen and Fish Identification as per DEEDI Fisheries website www.dpi.gov.au/28_630. as the standard references. The name of the species as shown on the "Eligible Species List" should be used, not a local name. **Note**; some species included for the Species Challenge are not eligible for National Records and Masters Award Claims and are indicated by a "Q".

11. DISPOSAL OF LITTER

Disposal sites for litter, fish offal etc. shall be defined by the club committee. The committee may disqualify competitors disposing of such elsewhere, where unsightliness or inconvenience to others may be caused.

12. INTERFERENCE

No competitor may cause deliberate unnecessary interference to another.

13. COMPETITORS UNABLE TO ATTEND THEIR OWN CLUB CHALLENGE MEETING

Competitors, including teams and/or members of a team not able to attend the Challenge Meeting at their own club, and individual members of ANSA Qld (Qld Sportfishers), invited to use the weigh-in facilities of another ANSA Qld Inc club, must relay their results to their own Club for processing. Where an angler's club has decided not to compete in the Species Challenge, then an angler may, by invitation, have their entry nomination and results processed and forwarded by a competing host club.

14. DATE OF SPECIES CHALLENGE

Shall be held on the last full weekend in September each year.

15. PRESENTATION OF AWARDS

The State Executive shall arrange and forward the awards to clubs for presentation as soon as possible after publication of the final results.

Awards shall be for the following:

- a) Champion Senior Team - The top scoring team of not more than three (3) persons.
- b) Champion Junior Team - The top scoring team of not more than three (3) juniors and/or sub-juniors.
- c) Champion Family Team
- d) State Individual Champion Senior Male.
- e) State Individual Champion Senior Female.
- f) State Individual Champion Junior Male.
- g) State Individual Champion Junior Female.
- h) State Individual Champion Sub-Junior Male
- i) State Individual Champion Sub-Junior Female
- j) Tagging

From (d) to (i) inclusive shall be the top scoring person in their grade.

A **Junior Competitor** is one who has attained the age of ten (10) years but not sixteen (16) years of age (see general rules page 13).

A **Sub-junior Competitor** is one who has not attained the age of ten (10) years (see general rules page 13).

Junior Teams (b)

Junior Teams may comprise both male and female juniors and/or sub-juniors.

The State Championship is determined by the top scoring team of not more than three persons; therefore a junior team can be the State Species Challenge team.

A junior team may not have a senior member nominated in it.

Juniors and sub-juniors may be members of a senior team but become ineligible for the junior team award.

Family Team Nomination (c)

- a. Must comprise of at least one senior and one junior/sub-junior member
- b. Can nominate as individual competitors or member of another team
- c. Family Team shall enter a maximum 3 member's species, with minimum one fish to be entered by a junior/sub-junior.
- d. Number of anglers in team is unlimited as long as the nominations are classed as being part of an accepted family. A family is defined as per ANSA Qld Inc membership category.

Tagging (j)

Provision has been made for a tag and release competition as part of the State Championships. The rules are the same as for the Tagging Masters Award, except as modified hereby:

Fish must be captured in a manner conforming to ANSA Qld Species Challenge Rules

Any angler competing in an ANSA Qld. Inc. affiliated competition where awards are given for tag effort then the angler recording the tagging of the fish must also be the angler who captured the fish. NB. As the focus for collection of tag data is on the data itself then this rule does not apply outside competitions.

Line classes have no bearing on point scoring.

Total points to be calculated using the allocated Tagging Points system (as per the Queensland Eligible Species List) and forwarded to the Events Coordinator.

Eligible species and points scored will be those nominated by the Suntag Coordinator. In some areas the tagging is project based so please refer to the species from those projects.

16. NOMINATION

- a) **Only members affiliated with ANSA Qld Inc (through membership of an affiliated ANSA Qld Inc Club or Qld Sportfishers) AND appear on the ANSA Qld Inc Membership Register prior to the start of the competition are eligible to compete.**
- b) All competitors and teams shall nominate with their club for the competition by 1800hrs of the Friday night immediately preceding the competition. **NB. The nomination form (Form ONE) is to be held by the club and then forwarded with the results sheets to the State convenor.**

17. PENALTIES

Any competitor who breaches any species challenge rules shall be disqualified, provided however that:

- a) The breach must be reported to the club committee prior to the completion of the weigh-in.
- b) The breach must be proven to the satisfaction of the committee.
- c) Not less than three (3) committee members shall constitute a quorum where a decision is required in relation to a reported breach of rules of this competition.

18. DISQUALIFICATIONS

- a) Shall be as defined in the National Rulebook and/or as otherwise provided for in these rules.
- b) Any competitor or team that is disqualified may lodge an appeal, in writing, with the State Executive within fourteen days of the competition. The State Executive, at their next meeting, shall hear this appeal. Their decision shall be final.

19. DECLARATION OF CHAMPIONSHIP

When the results are collated the State Convenor will advise all zones and clubs of the PROVISIONAL RESULTS as soon as practicable after the Challenge Meeting. After all of the "Summary of Results" forms have been received, they will be checked by the Events Coordinator who will then declare the OFFICIAL RESULTS.

20. ZONES

Zones are optional. Those clubs participating in Zones are encouraged to run a Zone Championship simultaneously with the ANSA Qld Species Challenge. Zones may additionally or otherwise organise functions and facilities for participating clubs.

A Zone committee may act instead of a club committee wherever reference is made to same throughout the rules.

ANSA QUEENSLAND BRANCH INC ELIGIBLE SPECIES LIST

1. Eligible species herein are listed in alphabetic order according to the first common name specified in the references used.
2. Common names have recently been standardised across Australia, so therefore some of the common names will be varied slightly. The Standard name has been substituted where required and the previous common name will still be included in brackets to help with the transition to the standard common name.
3. Scientific names are included where there is only one species for the common name. The terms "ALL SPECIES" and "OTHER SPECIES" substituted where there are multiple scientific names for a single common name. Some common names are separated where different legal sizes/fight factors occur. For full list of both common and scientific names refer to the species list on the web site www.ansaqld.com.au (Comprehensive List)
4. Refer to "Eligible Species List" for eligible species and fighting factors, with E.M.Grants "Guide to Fishes", "Fishes of the Great Barrier Reef and Coral Sea" by J.E. Randall, G.R. Allen and R.C. Steene and "Marine Fishes of Tropical Australis and South East Asia" by G. R. Allen, "Freshwater Fishes of Australia" by G.R. Allen, S.H. Midgley, and M. Allen and Fish Identification as per DEEDI Fisheries website www.dpi.gov.au/28_630. as the standard references.
5. **SPECIAL NOTE:**
 - a) Some species included are not eligible for National Record and Masters Award claims and are indicated by a "Q".
 - b) Certain species in the National Eligible Species List have been excluded due to their absence from Queensland waters.

The **size and bag** limits that are stated below are subject to constant review by the Queensland Fisheries Service and other state or federal bodies.

Please be aware of these changes when they occur and abide by the changes to size and bag limits. Many areas and species now have seasonal closures as well eg. Coral Reef Fin Fish closures. Fisheries laws can change at any time. **ANSA Qld Inc. will not be responsible for any member who breaks Fisheries laws.**

There are slight changes to fisheries regulations while fishing in stocked impoundments eg. you may have one barramundi in your possession during the closed season and that fish may be over 120cm **only if you catch the fish in a stocked impoundment.**
Note; Fish need to be tagged before leaving a stocked impoundment in some areas.

A combined take and possession limit of 20 will apply to coral reef fin fish (as listed in the Fisheries 'Coral Reef Fin Fish' management plan 2003), however within this combined limit, anglers must comply with individual take and possession limits for various fish species.

Please note: Gold Spot and Black Spot Cod are now listed as Coral Reef Finfish Species.

N.B. Please make yourself fully aware of the current regulations and any amendments.

This list now contains the Freshwater Species that attain a length of greater than 200ml. Some now regulated Freshwater species do not appear on this list because they do not reach 200ml. Please check against Fisheries Regulations.

Species with no Length or Factor are not Regulated fish and are therefore No Take species for ANSA Qld. (Species listed for identification only)
